Rauhoitettava alue.

Kunnanhallitus on 24.2.2025 tehnyt päätöksen ostaa tilat Östergård, Brutan ja Brutan 1.

Tilat ovat kooltaan yhteensä 19,625 hehtaaria. Tilat sijaitsevat Grundträskintien varressa.

Kiinteistöjen alue on varattu yleiskaavassa G 13 Sipoo 2025 merkinnällä MTH eli haja-asutusalueeksi.

Alue rajoittuu eteläpuolella olevaan Valtion omistamaan rauhoitettuun alueeseen ja itäpuolella olevaan matalavetiseen metsälampeen nimeltään Grundträsket.

Kommunstyrelsen har 24.2.2025 beslutat köpa lägenheterna Östergård, Brutan och Brutan 1.

Lägenheternas totala areal är sammanlagt 19,625 hektar. Lägenheterna finns längs Grundträskvägen.

Området har i generalplanen G 13 Sibbo 2025 försetts med beteckningen glesbygdsområdet.

Södra delen av området gränsar till ett fridlyst område som ägs av staten. Öster om området finns Grundträsket.

ME ALLEKIRJOITTANEET VALTUUTETUT ehdotamme , että kyseisten tilojen kaakkoisnurkka, kooltaan noin 3 – 5 hehtaaria rauhoitetaan esimerkiksi luonnon suojeleulain nojalla. Alueella kulkee hyvin suosittu luonnonvarainen polku. Polun kunnossapitämisen ja kunnostaminen tulee mahdollistaa suojeleusta huolimatta. Samoin polulle kaatuneet puut ja ulkoilijoille vaarallisiksi luokiteltavat puut tulee saada postaa.

VI UNDERTECKNADE FULLMÄKTIGELEDAMÖTER föreslår att ett ca 3-5 hektar stors område i lägenheternas sydöstra hörn fredas till exempel enligt naturskyddslagen. På området där fredning är föreslagen, finns en mycket använd promenadstig. Stigens underhåll och förbättringer bör tillåtas trots fredningen. Dessutom bör tillåtas borttagning av träden som fallit på stigen samt träden som förorsakar fara för människor som rör sig på stigen.
